Call to order by Chairman James Wade.

Sheriff Joe Russell advised Board of County Commissioners that he will not move the Sheriff's dispatch system to the proposed E-911 Emergency Management Dispatch Center once it becomes available. Board informed Russell that the E-911 system could be years away from being completed. Toni Peery, E-911 Committee Chairperson, addressed the Board in reference to Russell's declaration and informed them she advised Russell of two different ways that other counties had linked with E-911 and had asked him his opinion on how he wanted to precede with the dispatching. She also explained that it was not the intent of the committee to "cut-off" the dispatch service for the Sheriff's Department and that the committee had wanted the Sheriff's input on the subject. Russell was very direct on his opinion of keeping the Sheriff's dispatch center.
